CONSENT FORM - RADIO WORKS!

PURPOSE: The purpose of this research is to collect and conserve life stories from individuals displaced or otherwise affected by war, genocide or other human rights violations individuals. Those in charge of this project hope to have these life stories known to researchers and the general public in order to create awareness around these issues. For the Radio Works! component of the *Montreal Life Stories* project, the purpose of the interview is to discuss questions and issues related to the *Montreal Life Stories* project, the specifics of which shall be agreed upon verbally, by the interviewer and interviewee, prior to the interview. Organizers of Radio Works! intend to broadcast these recorded and edited conversations and any other agreed upon audio on either CKUT 90.3 FM, CIBL 101.5 FM, CBC Radio or another agreed upon community or public radio station, as well as to post the edited pieces on both the CITIZENShift and *Montreal Life Stories* websites, in order to raise public awareness about the project and its research.

PROCEDURES: The interview will be conducted at participants' homes, at facilities provided by Concordia University, at a radio station studio or at another appropriate place agreed upon by the interviewee and interviewer. Interviewers will record the interview and/or any other agreed upon audio using an audio recorder. Participants can choose to discuss any aspect of their lives or work, depending on the agreed-upon topic, and the interviewer and interviewee should discuss an appropriate duration for the interview beforehand. Participants are free to stop at any time. If necessary, more interviews will be conducted.

COLLABORATION: In the spirit of the shared authority ethic of the *Montreal Life Stories* project, the interviewee will be asked to participate in the editing of the recorded interview and/or audio, to the extent that s/he or wishes to do so. This collaborative process is recommended to ensure that the interviewee feels comfortable with and consents completely to the final audio which is broadcast on the radio and disseminated on the Web. The collaboration can involve any variation from sitting with the interviewer to edit the piece, being provided a copy of the unedited interview to suggest changes or listening to the final edited piece before its public broadcast to approve and consent to it. This degree of collaboration is to be agreed upon verbally by the interviewee and interviewer at the time of the interview.

RISKS: Describing difficult experiences can be troubling and traumatizing on an emotional level. If at any time the person being interviewed feels overwhelmed by his or her emotions or if he or she wishes to speak with someone it is possible to refer to the list of resources attached to this document.

CONDITIONS OF PARTICIPATION: Please review the following conditions and options with the interviewer. Feel free to ask questions if they appear unclear.
